3. List of publications (16 photocopies).
4. One set of publications.
5. Correspondence address with Telephone/Mobile numbers and E-mail address.
6. Consent of nominee (one original set and 15 photocopies of each set).

These recommendations are to be forwarded by nominator.

The nomination should mention clearly the category under which it is to be considered.

Persons who had been nominated earlier and not selected are eligible for re-nomination.


