

Hospitals, Medical Directors of empanelled private hospitals & diagnostic centres, Medical Directors of identified private hospitals, elected representatives, etc. for increasing awareness amongst the public regarding these schemes and sensitizing the stakeholders.

Hon'ble Chief Minister, GNCTD will launch the free surgery scheme in private hospitals and will address the stakeholders during the workshop.

All doctors including Teaching Specialists, Non-Teaching Specialists, GDMOs, Senior Residents & Junior Residents and nurses including Nursing Superintendent, DNS, ANS, PHN & Nursing Sister of all Wards, OPD etc. posted in Delhi Govt. Hospitals, Medical Colleges, Polyclinics, Dispensaries, AAMCs, DGHS, DFW, O/o CDMOs, DSHM and in various wings/ establishments of Deptt. of Health & Family Welfare are required to attend the said workshop.

Only doctors and nurses who are either posted in the night shift of 07.07.2017 and evening & night shift of 08.07.2017 or who are on pre-sanctioned leave are exempted from attending the workshop.

This is for strict compliance and all HODs/ HOOs are requested to ensure that doctors & nurses from their respective institution/hospital are seated latest by 3:30 PM.


